Item 4. Ownership

(a) Amount beneficially owned:

As of the close of business on December 31, 2019, the Reporting Persons held 4,512 shares of Series A Convertible Preferred Stock (the “Series A Preferred”) convertible for an aggregate of 4,512,000 shares of Common Stock. The Series A Preferred may not be converted if, after such conversion, the Reporting Persons would beneficially own, as determined in accordance with Section 13(d) of the Securities Exchange Act of 1934, more than 9.99% of the number of shares of Common Stock then issued and outstanding (the “Series A Blocker”). As of the close of business on December 31, 2019, the Series A Blocker limits the aggregate conversion of Series A Preferred by the Reporting Persons to 4,491,000 out of the 4,512,000 shares of Common Stock underlying the Series A Preferred owned by the Reporting Persons in the aggregate. In providing beneficial ownership described herein, the Reporting Persons have assumed that all of the Series A Preferred held by BVF to acquire 2,220,000 shares of Common Stock, all of the Series A Preferred held by BVF2 to acquire 1,847,000 shares of Common Stock, all of the Series A Preferred held by Trading Fund OS to acquire 326,000 shares of Common Stock, and certain of the Series A Preferred held in a certain Partners managed account (the “Partners Managed Account”) to acquire 98,000 shares of Common Stock, would be converted, which would bring the Reporting Persons to the aggregate 9.99% limitation, and the remaining Series A Preferred convertible into 21,000 shares of Common Stock held in the Partners Managed Account would not be converted due to the Series A Blocker.

The Reporting Persons may choose to convert the Series A Preferred in other amounts among the Reporting Persons, while continuing to comply with the Series A Blocker.

As of the close of business on December 31, 2019, (i) BVF beneficially owned 2,653,587 shares of Common Stock, including 2,220,000 shares of Common Stock issuable upon the conversion of certain Series A Preferred, (ii) BVF2 beneficially owned 2,066,376 shares of Common Stock, including 1,847,000 shares of Common Stock issuable upon the conversion of certain Series A Preferred, and (iii) Trading Fund OS beneficially owned 362,877 shares of Common Stock, including 326,000 shares of Common Stock issuable upon the conversion of certain Series A Preferred.

BVF GP, as the general partner of BVF, may be deemed to beneficially own the 2,653,587 shares of Common Stock beneficially owned by BVF.

BVF2 GP, as the general partner of BVF2, may be deemed to beneficially own the 2,066,376 shares of Common Stock beneficially owned by BVF2.

Partners OS, as the general partner of Trading Fund OS, may be deemed to beneficially own the 362,877 shares of Common Stock beneficially owned by Trading Fund OS.

BVF GPH, as the sole member of each of BVF GP and BVF2 GP, may be deemed to beneficially own the 4,719,963 shares of Common Stock beneficially owned in the aggregate by BVF and BVF2.

Partners, as the investment manager of BVF, BVF2 and Trading Fund OS, and the sole member of Partners OS, may be deemed to beneficially own the 5,225,301 shares of Common Stock beneficially owned in the aggregate by BVF, BVF2, Trading Fund OS, and the Partners Managed Account, including 142,461 shares of Common Stock, which includes 98,000 shares of Common Stock issuable upon the conversion of certain Series A Preferred, held in the Partners Managed Account.

BVF Inc., as the general partner of Partners, may be deemed to beneficially own the 5,255,301 shares of Common Stock beneficially owned by Partners.

Mr. Lampert, as a director and officer of BVF Inc., may be deemed to beneficially own the 5,255,301 shares of Common Stock beneficially owned by BVF Inc.

The foregoing should not be construed in and of itself as an admission by any Reporting Person as to beneficial ownership of any shares of Common Stock owned by another Reporting Person. BVF GP disclaims beneficial ownership of the shares of Common Stock beneficially owned by BVF. BVF2 GP disclaims beneficial ownership of the shares of Common Stock beneficially owned by BVF2. Partners OS disclaims beneficial ownership of the shares of Common Stock beneficially owned by Trading Fund OS. BVF GPH disclaims beneficial ownership of the shares of Common Stock beneficially owned by BVF and BVF2. Each of Partners, BVF Inc. and Mr. Lampert disclaims beneficial ownership of the shares of Common Stock beneficially owned by BVF, BVF2, Trading Fund OS, and held in the Partners Managed Account, and the filing of this statement shall not be construed as an admission that any such person or entity is the beneficial owner of any such securities.

(b) Percent of class:
